In support of strengthening student academic achievement, **John M. **DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT  
REQUIRED SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS**

**Section A: JOINTLY DEVELOPED**

**John M. Patterson** will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

**Mr. Jessup invites all parents into the auditorium on the first morning of school to welcome them, to review our academic expectations, and to review our student handbook. During our Annual Title I meeting held in the fall, we review via powerpoint presentation, the requirements of Title I part A, parent rights to know, state and local assessments including the PSSAs, school curriculum, how to work with educators and to track student progress. In October, we will hold our first Family Night. During this time, we will get additional parental input on improving our parental engagement and academic success. We also give parents a short survey to hear their thoughts and ideas about our school, parent involvement and ways we can strengthen our parental engagement.**

**Our Family Nights will be held every two month, the first 15 minutes of each workshop will discuss Parental Engagement and academic success for all. Parents are invited to the Winter Title I meeting to review and give input into the school budget and school improvement plan. In the Spring, parents are invited to give their input into this policy and the compact. This policy was updated based on parent input that was solicited at a meeting on April 2020.**

**Each term there will be School Advisory Council meetings for the opportunity for parents to discuss their ideas for their child's education.**

**Section B: ANNUAL TITLE I MEETING**

**John M. Patterson** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

**John M. Patterson will hold the Annual Title I Meeting in September on Back to School Night. Parents will be informed of the requirements of Title I and the school's participation as well as the parents' rights to be involved. Also at this meeting, parents will be given information about the state's academic content standards and assessments, ways to work with educators, and strategies and systems in place to help parents monitor student progress. This will be an opportunity to distribute information and copies of the revised Parent and Family Engagement Policy and School-Parent Compact. flyers are sent home notifying of meeting dates. Meetings are held in the early evening to accommodate parent schedules and increase participation. Outdoor marquee(sign) and our website notifies parents of important dates and activities. All school district correspondence is available, at our parent information center, in various languages. Interpreters, through the school district, are available. Translations to any document can be made upon request. All parent communications are sent home in parent-friendly language.

#### **Section G: BUILDING CAPACITY OF PARENTS**

**John M. Patterson** will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

**Parent workshops are held throughout the year on the following topics: Google Classroom, Site Selection, Imagine Math, Lexia, Literacy and Math and Health and Wellness. During report card conferences, three times a year, parents are shown how to monitor their child's progress. Interim reports are also sent home three times a year. At the Annual meeting, held in the fall, parents are given information about the requirements of Title I, Part A, as well as the State's academic standards and assessments, how to work with educators and monitor student progress, and information about the school curriculum and academic programs.**

**Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement.**

**Professional Development Training for all staff will be given in the Fall, Winter and Spring. Topics include Parents as Equal Parents, Cultural Awareness, and Making Parent Involvement Meaningful. Joint parent-staff SAC meetings are held to aid in being a "Patterson Team." We have a few parent volunteers. They work in classrooms, monitor hallways and the yard, assist with class trips, etc. All parents have the proper required clearances. Parents are also encouraged, throughout the year, to give feedback by completing a half page survey. These surveys are reviewed by administration and shared with staff during district PD days in the Fall and/or Winter as results become available.**

**John M. Patterson** will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

**Patterson has an open-door policy for a parent's concerns regarding their child's education or safety. Family Nights(every 2 months) and SAC meetings(3 times a year) are offered to all parents. Parents are invited to seasonal and award assemblies. Home visits are conducted for attendance.**
