

# John M. Patterson School Parent and Family Engagement Policy

In support of strengthening student academic achievement, John M. # Section A: JOINTLY DEVELOPED

John M. Patterson School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

John M. Patterson has two Kindergarten Open House a year. Our pre-K Program(in our schoolyard building) and all neighboring daycare centers are invited. We also have a Building Bridges Meeting to build connections among these pre K programs. Invites are distributed to neighborhood daycares and to the parents in the Pre-K building. School District provided Flyers are also distributed to neighborhood stores. We also have a Parent Resource Desk, where parents can find information on FACE (Family and Community Engagement), community child care, health care, discounts on internet services, school selection, school report cards, etc. Patterson school also partners with the following organizations:

Partnership with John Heinz refuge: teaches fourth grade lessons at school, offers monthly trips to Heinz.

Partnership with Pacifico Ford: donates 100 coats for our students

Eat Right Philly: teaches healthy eating habits to students and parents

Partnership with Southwest Presbyterian Church: fundraising for needy "can drive"

Partnership with Bartram Gardens for grades K through 2.

# Section G: BUILDING CAPACITY OF PARENTS

John M. Patterson School will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

During report card conferences, three times a year, parents are shown how to monitor their child's progress. Interim reports are also sent home three times a year. At the Annual meeting, held in the fall, parents are given information about the requirements of Title I, Part A, as well as the State's academic standards and assessments, how to work with educators and monitor student progress, and information about the school curriculum and academic programs.

#### Section H: BUILDING CAPACITY OF SCHOOL STAFF

John M. Patterson School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Professional Development Training for all staff will be given in the Fall, Winter and Spring. Topics include Parents as Equal Parents, Cultural Awareness, and Making Parent Involvement Meaningful. Joint parent-staff SAC meetings are held to aid in being a "Patterson Team." We have a few parent volunteers. The Volunteers work in classrooms, monitor hallways and the yard, assist with class trips, etc. All parents must have the proper required clearances. Parents are also encouraged, throughout the year, to give feedback by completing a half page survey. These surveys are reviewed by administration and shared with staff during district PD days in the Fall and/or Winter as results become available.

John M. Patterson School will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

Patterson has an open-door policy for a parent's concerns regarding their child's education or safety. Family Nights(every 2 months) and SAC meetings(3 times a year) are offered to all parents. Parents are invited to seasonal and award assemblies. Home visits are conducted for attendance.
